Trade Conditions and Waiver

1. Your business is required to hold a **Public Liability Policy with minimum cover of \$20M** and a copy of your **current Certificate**, is to be provided with your application.
2. **Full payment** is required at time of lodging your application. This fee will be refunded if you provide notification of cancellation, **by 5.00 PM, on the Monday** prior to the Gloucester Spring Plant Fair.
3. Stallholders shall not assign or sublet any part of allocated space without the consent, in writing, of the Gloucester AH & P Association. The site allocated **MUST NOT** be changed without the approval of the Gloucester AH & P Association.
4. No trader shall excavate, dig or place pegs/pickets/spikes in the allocated area without obtaining permission from the Gloucester AH & P Association.
5. Trade sites must be assembled and operational **by 9.00am** on the Saturday of the Gloucester Spring Plant Fair.
6. Traders are required to staff their displays from **9.00am – 4pm** on the Saturday, and **9.00am – 1pm** Sunday. **No displays can be dismantled or removed before 1pm on Sunday without the permission of the Gloucester AH & P Association.**
7. Standards of Exhibition: Traders must ensure that Trade Exhibits are of an appropriate standard and do not constitute any danger or cause offense to persons attending the Gloucester Spring Plant Fair. This regulation includes the use of microphones, machine demonstrations and audio-visual displays.
8. The Gloucester AH & P Association has the authority to remove, or have removed any sign or article that may offend the public.
9. A delegate, nominated by the Gloucester AH & P Association, is empowered to enter any Trade Space Exhibit, for the purpose of inspection at any time during the Gloucester Spring Plant Fair.
10. Electrical Notice: Any exhibitors intending to bring electrical equipment to the Gloucester Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor, to comply with the Workplace Health and Safety Act 2011.
11. Vehicles must be removed from the Gloucester Spring Plant Fair area of the Gloucester Showground **BEFORE 8.30** am on the Saturday, and **BEFORE 8.30** am on the Sunday, unless they are food vans. All stallholders are requested to organise deliveries prior to this time and notify your suppliers of this condition.
12. Site fees will be charged on site size as per the Application forms and are listed below:
 - i. **Tent – refers to all small portable shelters that are not mobile, and require assembly before use**
 - ii. **Small Vehicle – refers to all vehicles that are no larger than 18 feet/6m**
 - iii. **Large Vehicle – refers to all vehicles that are larger than 18 feet /6m**
13. The Gloucester AH & P Association, may attempt to minimise the duplication of trade stalls of the same goods and/or services as we encourage a diversity of vendors, however the Gloucester Spring Plant Fair does not provide exclusion sale rights.
